The MOE FAS is a voluntary scheme for the purpose of providing financial assistance to students who are financially needy and who are enrolled in full-time education in Singapore.

**ELIGIBILITY CRITERIA**

1. Students who are currently enrolled in full-time education in Singapore and who are financially needy.
